The program provides participants with key knowledge on public procurement, focusing on value for money, compliance with regulations, and supporting Lebanon's Public Procurement Law no. 244/2021.

Pathway to advanced studies in public procurement

This program is a pathway to pursue the International Master in Public Procurement Management (IMPPM) at the University of Rome Tor Vergata in Italy, a full time, advanced, postgraduate and internationally-recognized Master. Successful participants to the Certification program who wish to pursue their learning or a career in public procurement are encouraged to apply to the IMPPM.

Program Highlights

Dive deep into diversified topics such as the new Public Procurement Law in Lebanon, international regulations, integrity, sustainability, complaints handling, and others delivered in the English and Arabic languages.

Access a unique learning experience combining theoretical instruction with a practical approach and simulations, and a networking opportunity with peers in the field.

4. Blended Learning Model

Program Structure

Training delivery

- The program is composed of high-level training courses designed to enhance the skills and knowledge of procurement officials. It is built on 50 hours of immersive learning experience spread over 5 weeks between April and June.
- Participants have to expect a balanced and manageable work-load of a 10-hour training distributed over 2 days per week.
- Participants have to undertake the certification exam following the training courses.

Work-based assignment

After the training, participants have to complete and submit a work-based assignment.

Study visit to Rome

Top achievers will be invited to a study visit to Rome where they will have the opportunity to attend the Global Procurement Conference organized by the University of Rome Tor Vergata.

Topics

- Public Procurement Law 244 Arabic (10 hours)
 Explore Lebanon's new Public Procurement Law (PPL)
 244/2021, its principles and provisions for achieving governmental policy objectives.
- International Public Procurement Regulations
 (UNCITRAL, OECD, EU, WTO/GPA)
 (10 hours,
 Grasp global perspectives on regulations, principles, and practices governing public procurement from UNCITRAL, WTO/GPA, OECD, and EU.

3. Integrity and Anti-Corruption (10 hours)

Network and exchange experiences on anti-corruption policies, ethical considerations, and beneficial ownership transparency in public procurement.

- 4. Sustainable Public Procurement (10 hours)
 Explore the strategic role of public procurement in economic growth, environmental protection, and social inclusion, aligning with SDG 12.7.1.
- 5. Handling Complaints (10 hours)
 Stay current on effective complaint handling mechanisms, enhancing efficiency and trust while understanding key players' roles.

Assessment

The assessment is designed to drive participant motivation for learning and engagement with experts and peers through:

- Multiple-choice exam at the end of each training module;
- Work-based assignment: a written essay based on a work-related case study.

Participant's attendance and active participation are key to optimize the learning experience.



Beneficiaries

Target Audience

Procurement practitioners and specialists seeking to upgrade their knowledge and skills in strategic public procurement.

Prerequisites

- 5 to 10 years of experience in areas related to public procurement (such as public finance, audit, accounting, engineering, etc).
- Proven work experience of at least 3 years in public procurement, preferably in managing teams.
- University degree or equivalent in any of the fields related to public procurement (economics and finance, business management, accounting, law, engineering, information and technology, political science and administration, etc).
- Working knowledge of English.
- Willingness to sit for a final examination and to commit to program requirements.
- Shall not be a holder of the IMPPM diploma delivered by the University of Rome Tor Vergata.





How to Apply

Submit the Online Application Form by the set deadline.

The selection process will be based on the program prerequisites.

Shortlisted candidates will be invited to undertake a knowledge test to demonstrate their suitability for the program.

A final selection will follow.
